### **Sub: Payment of Levy on Arrears of DA/Basic for members who retired from 1998 to 2005.**

We draw the attention of our members to our Circular No UBRA-KAR/CIR/040/2017-2020 17/06/2018 wherein we had listed out the levy to be paid by members to our Association on receipt of the Arrears of DA for members who retired during 1998 to 2005. The chart is given below once again for information

The chart is as follows:

Arrears received up to Rs 50,000-	Rs 2,500/-
Arrears received up to Rs 50,001 to Rs 1,00,000	Rs 2,500 + Rs 1,000 = Rs 3,500/-
Arrears received up to Rs 1,00,001 to Rs 1,50,000	Rs 3,500 + Rs 1,000 = Rs 4,500/-
Arrears received up to Rs 1,50,001 to Rs Actuals	Rs 4,500 + Rs 1,000 = Rs 5,500/-

We are informed by some members that they have receiving the arrears of payment to their account. We are not aware how the arrears are being calculated and how much each member is likely to receive. We also do not know the sequence of payment as the amounts are coming in random fashion and not the PF Number or the Date of retirement.

We therefore request members to have some patience and the process of payment has begun.

Meanwhile we advice members to pay the Levy by CHEQUE with your name subscribed and post it to Sri B Lakshminarayana, Deputy Secretary. In case any member wishes to remit the levy by Net Banking, he/she may do so. In that event please inform Sri Lakshminarayana by SMS/Whats App
