**Sub: Demonstration and Dharana before Town Hall, Bangalore**  
**Ref: Non Settlement of Issues relating to Retirees in Public Sector Banks.**

Members are aware that all of us had a lot of expectations from the 10th Bipartite Settlement between UFBU and IBA regarding the improvement of Pension and related matters of the Pensioners/Retirees in Public Sector Banks. However, the final outcome of the settlement has let down the retirees on the demands made by us. We have seen that IBA has brushed aside the request of UFBU to discuss the matters relating to Retirees and have said that UFBU has no locus and that Banks Managements had given mandate to IBA to only discuss matter relating to serving employees. However some sort of an eyewash was made owing to the protest by UFBU and a Record Note" was added as a post script.

While we may not go into the blame game and also the causes of the fiasco, our Apex organisation has decided that all Retiree organisations should fight their own battles. As a result of the decision a coordination of all retirees organisations was convened where major Retiree organisations like All India Bank Retirees Federation, Retired Bank Officers National Confederation and All India Bank Pensioners and Retirees Confederation and All India Federation of SBI Retirees Federations was formed.

The Coordination of Bank Retirees met in Delhi on 22nd September 2015 and drew an plan of action for focusing the issues of Pensioners .The action plan inter alia has a plan to demonstrate in Jantar Mantar in New Delhi on the 11th of December. (The dharna and demonstration was held in New Delhi yesterday)

In the last General Body Meeting of our Confederation held on 15th of November at Kolkata. It was decided that a that we also need to hold demonstrations at various State Capitals under the banner of the Coordination Committee. In pursuance of the decision, the local chapter of AIBPARC (Karnataka) has organised a dharna and demonstration in front of Town Hall, Bangalore of the 17th of December between 11.00 a.m. and 1.00 p.m. Units affiliated to AIBPARC has been advised to mobilise as many members as possible so that the dharna will be very effective and bring to focus to the public at large the issues of our Bank Retirees.

In view of this we request all our members to gather at the venue of Town Hall on the 17th of December 2015 by 11.00 a.m without fail. We also advise members to talk to every members and ensure a large attendance on that date. PLEASE ATTEND THE DEMONSTRATION WITHOUT FAIL
