In the Meeting of the representatives of affiliates of CBPRO(Karnataka) organised at the Meeting Hall of SBIOF, Local Head Office, SBI, St.Mark's Road, Bangalore, it was unanimously resolved to chalk out action programme (s) under the banner of CBPRO to draw the attention of the general public and the media towards the grievances of the pensioners and retirees in the Banking Industry. As the legitimate demands of the Bank pensioners have remained unresolved, we have no other alternative than coming to the streets and agitate. This unfortunate situation has been thrust on us by an unconscientiously IBA. Injustices against pensioners that could have been removed by IBA, have continued with impunity. We have to plead with IBA, we have to petition to public functionaries such as Members of Parliament in the State, Ministers in the Central Government and we have to reason with powers that be. As a first step to our direct action, it is decided to stage Candle Light Vigil, followed by submission of Memorandum to the Parliament Members and Central Ministers from Karnataka, call on the MDs & CEOs of Bangalore Head Quartered Public Sector Banks and submit a memorandum to them.
