AIBPARC held its Governing Council Meeting at Kolkata on 19th Jan, 2017. In response to the General Secretary's Report the leaders from various affiliates felt that delay in settling the issues of pensioners in Banking Industry is causing great depression, frustration, despondency among the pensioners. Neither IBA is serious about settling the issues nor the Government has shown any inclination to settle the long pending, justified demands. We should resort to serious action programmes to drive home the burning issues. The members in voice urged the leadership to launch action programmes such as Dharna in front of IBA HQ or at Jantar Mantar or March to Parliament. As all our efforts to convince the powers that be the need to settle the issues have failed we have no other go than launching these extreme steps to invite the attention of the people who matter. After lengthy deliberations it is decided to take a delegation of Office bearers of AIBPARC and CBPRO to IBA on 15th Feb, 2017 and hold Dharna where the Office bearers of CBPRO will observe fast for one day on 25th March 2017 at Jantar Mantar, Delhi. All the affiliates have felt the need to give wide publicity by spending some money for the same. A detailed communication will be issued by our Central Office at Kolkata. Friends, the issues have become elusive despite of our best efforts. All the affiliates of AIBPARC have resolved to make both the events a big success. Friends, our patience is being tested and time has come for us to give a battle cry for realisation of our hopes and aspirations. Please await for the communication to be issued by our Gen.Sectetary, AIBPARC.
