<u>SUB: Renewal of IBA Medical Insurance Scheme for Retired Employees for the period from 01.11.2020 to 31.10.2021 – Clarifications on Revised guidelines .</u>

In continuation of our circular no.0255, we draw your attention to Head Office circular no. CHO/ PMG/ 32/ 2020-21 dated.06.10.2020 communicating the revised guidelines for renewal of IBA Health Insurance Policy for the year 2020 – 21.

As per the provisions there in - Super Top –Up policy is only available to retirees who opt 3 Iac and 4 Iac Sum Insured in Base policy. Award Staff can opt for 1 Iac to 4 Iac sum insured in Super Top –Up policy. Officers can choose any choose any sum insured from 1 Iac to 5 Iac in Super Top- Up policy. Officers who opt for 3 Iac SI are eligible to avail up to 4 Iac Super Top – Up.

Keeping in view the provisions we are giving below the total premium applicable for various categories of retirees opting to avail Super Top – Up cover.


