

Sub: Renewal of Medical Insurance Policy for Bank Retirees.

We have received copies of the letters sent by you to Comrade S. K. Bandlish, Convener UFBU and to Shri S.K.Kakkar, Sr. Advisor (HR&IR), IBA regarding the Medial Insurance Premium in respect of Bank Retirees. In this connection we also refer to our telephonic discussion requesting you and other UFBU leaders to take up the issue with IBA. We are immensely pleased and thankful to you for taking up the issue with the UFBU and IBA clearly explaining the steep increase in the premium amount from the year of introduction (2015 and the proposed premium for the year 2019-20). The premium has jumped from Rs5620/- for Retired employees to Rs24897/- as proposed for 2019-20 and for Retired Officers from Rs7593/- to Rs33193/-. You have also urged upon the IBA to take such other measures which will help reduce the premium rate for the Retirees. We understand that the IBA has called for a meeting of the General Managers of the Banks on 18.9.2019 to discuss the Renewal of Medical Insurance Policy for Bank Retirees and give final shape to the policy for the year 2019-20. We also understand that IBA has called for a meeting of the Negotiating Committee on the 17.9.2019(Tuesday). We wish early and successful completion of WAGE TALKS and along with other issues of Bank Retirees contained in the RECORD NOTE of last wage settlement. We are also confident that the UFBU will succeed in making the Medical Insurance Premium affordable as per the suggestions given by us to UFBU and IBA vide our letter dated 02.09.2019 and 06.09.2019 with substantial amount of subsidy from the Bank. We once again thank you for the initiative taken by you and other UFBU constituents.
