AIUCBOF Welfare & Benevolent Trust has also issued a circular on various schemes of the Trust and the same is attached.


For the convenience of members, the Association is setting up a Help Desk at the following address:

Sub: AIUCBOF Welfare & Benevolent Trust Schemes in a nutshell

The Board of Trustees of AIUCBOF Welfare & Benevolent Trust in its meeting held on 3rd March, 2024 decided to revisit the following schemes and benefits of the Trust:

- a) New members for the trust will be admitted with immediate effect. Those desirous serving / retired officers / supervisory staff who have not enrolled as members of the trust shall now be enrolled on payment of Rs.3010/- for serving officers and Rs.10010/- for retired officers. The application for new membership is Annexure 1.
- b) The annual donation to be eligible for mediclaim reimbursement is slashed to Rs.3000/- for retired members and Rs.2000/- for serving members. The limit of reimbursement would be restricted to Rs.3 lakhs. In the case of retired members who have a base policy (with or without Top-up) of less than Rs.3 lakhs the reimbursement would be restricted to the maximum amount reimbursed by the TPA/Insurance Company. The new mediclaim scheme for the year 2024-25 will open on 1st April 2024. The form for making donations is attached herewith as Annexure 2.
- c) If donations of continuing members in medical-aid scheme of the Trust reach our office at Kolkata by 30-04-2024, they will be reimbursed hospitalization expenses from April 01, 2024. For others a month from the date of receipt of donation only will be entertained. In other words, the donation can be made any time during the year but the claims would be restricted to reimbursement for hospitalization after a month of receipt of donation. The claim for medical reimbursement is Annexure 3.

- d) There is no change in the reimbursement of Rs.1000/- for every four years for those members who avail holiday homes of the Bank or any other hotel in any holiday destination. The claim form is Annexure 4.
- e) The meritorious children awards would continue as before. There is no change in it. The claim form is Annexure 5.
- f) The death relief for the members who unfortunately die in harness or are permanently disabled due to any accident remains enhanced to Rs.1.5 lakhs from the existing Rs 75000/-. The claim form is Annexure 6.
- g) The orthopedic equipment reimbursement for retired members remains the same as Rs.2000/-. This is one time. The claim form is Annexure 7.
- h) Guest house facility of Trust to its members closed since 2020 shall be commenced soon after necessary face-lift.

We request more members to donate for the medical reimbursement scheme to enable that all the members in need are benefitted. Greetings.
