**SUB: Renewal of IBA Medical Insurance Scheme for Retired Employees for the period
from 01.11.2025 to 31.10.2026.**

Head Office vide their circular no. CHO/PMG/24/2024 - 25 dated.20.09.2025 has issued the necessary guidelines for renewal of the said policy. Members are requested to study this circular carefully to know all the terms and conditions and the applicable premium.

The following are the important points to be noted in this regard.

1. A fresh option is to be submitted online by the retiree / spouse of the deceased employee /retiree who want to renew their IBA Group Mediclaim Insurance policy for 2025 - 26. **Link is provided at Bank's website www.uco.bank.in – staff pensioner's corner – Medical Insurance for Retired Employees (2025-26).**
2. The employees who have retired between 01.11.2024 to 31.08.2025 and who will be retiring on or before 31.10.2025 will have the option to join the Medical Insurance Policy for the year 2025 – 26.
3. There is no need to submit hard copies of application to Personnel Services Department, Head Office.
4. Those retirees / spouse who had not subscribed to the current insurance policy will also have the option to join.
5. **The last date for submission of online application is 12th October 2025.No extended window will be allowed for enrollment under Retiree Base and Top – up policy 2025 – 26.**
6. **Head Office will be debiting the premium from 13.10.2025 to 15.10.2025 in batches.**
7. **It will be responsibility of the retiree / spouse to maintain the necessary balance in their respective account from 13th to 15th October 2025.**
8. Our Association is setting up a **Help Desk** in the "UCO BANK Officers Association Office", 3rd Floor, UCO Bank Building, K.G. Road, Bangalore - 560009 **on 8th, 9th and 10th October 2025 between 11 AM and 2 PM.** Members are requested to make use of the facility for renewal of the policy.


