#### Sub: Need for additional super top up coverage for Retirees to meet the increased Hospitalisation cost in the present corona-scared world of ours.

We draw your kind attention to Circular SL no 159/2021--22 dated 19.05.21 issued by P&HRD department of State Bank of India under the signature of DMD(HR) & Corporate Development Officer on the above mentioned subject.

Although We are aware of the fact that the scheme prevalent in SBI is not exactly the same with what is in force at the IBA scheme, still it is surely a path-- finder in this difficult situation. It acknowledges that the present coverage of health insurance is becoming inadequate in the wake of the increased medical/ hospitalisation expenses and spiralling cost of Covid 19 treatment and SBI General Insurance company Ltd has agreed to provide additional super top up coverage.

It is obvious that the proposed additional coverage with substantial increase in quantum will be optional, floater--based with provisions of pro- rata payment for availment in the mid--year and also requiring some larger sacrifice on the part of the willing Pensioners to avail the additional super top up limits. In other words, We strongly feel that a re--look into the existing policy is a need of the hour and We call upon IBA to start negotiation with the Insurance Company to offer instant relief by adhering to the spirit and contents of the referred Circular.

We shall consider it a favour if you kindly take an urgent note of the issue.
