**SUB: FORM 26 AS FOR THE FY 2020 - 21 (ASSESSMENT YEAR 2021 - 22).**

Our Bank has completed the filing of returns pertaining to Q 4 for the FY 2021 ( AY 2021-22) and few of the members who have checked the same have come across few discrepancies such as :

- (1) Wrong TDS amount on account of deposits
- (2) Pension disbursed to other staff are wrongly reported in other staff member
- (3) Actual Pension disbursed to you are not appearing.

Members are requested to immediately Check their 26 AS and discrepancies if any be brought it to the notice of the **Head- Office** Finance Dept and Pension cell by email ([hoacs.calcutta@ucobank.co.in](mailto:hoacs.calcutta@ucobank.co.in) & [ucohopension@ucobank.co.in](mailto:ucohopension@ucobank.co.in) ) seeking immediate corrections as the due date for filing returns is approaching and correction returns are filed once in a while. This has to be done immediately as any excess income / wrong amount reported in Form A6 AS may result in reopening of your IT Returns. Ensure that proper reporting is done in Form 26 AS before filing your IT returns.
