21.12.2018 and UFBU on 26.12.2018.

You are aware of the fact that AIBOC announced 24 hour Nationwide Strike on 21.12.2018 demanding * Full and complete Mandate for Officers (Scale I to VII) in Bipartite Settlement, * opposing merger of Banks and RRBs,* introduction of Five day week,* Salary revision as per charter of demand, * settlement of Retirees issues including Family Pension / Updation of Pension,* *Focus on core business and recovery, * Scrapping of NPS and switching over to defined pension scheme and several other important issues. You are also aware that UFBU called a strike on 26.12.2018 opposing Government decision on amalgamation of Bank of Baroda, Dena Bank and Vijaya Bank.
