We have been taking up with IBA and Government of India about our Pending issues including submitting Memorandum to your good self and IBA personally. However none of the issues raised by us has been resolved disappointing all Banks Retirees & Pensioners who had put in their dedicated service in their respective Banks and served the nation as well.

Since no favorable developments have taken so far All Banks Retirees Organisations have called for demonstrations and dharna in all important centers and state capitals of India. Accordingly Dharna-Cum-March to Parliament is organised in Jantar Mantar, Delhi on 7th January, 2019(07.01.2019) Monday.
